The Vice-Chancellor gives notice that he has accepted with gratitude the following benefactions, of which both the capital and the income may be used:

- a benefaction of £500,000 from Newton Investment Management Limited, payable over five years, to support the Centre for Endowment Asset Management in Cambridge Judge Business School, during which period the Centre shall be known as the Newton Centre for Endowment Asset Management;
- (ii) donations amounting to £408,295 and £476,721, which have been contributed by subscribers to appeals for support in the fitting out of Eton Fives and Rugby Fives courts respectively in the Sports Centre;
- (iii) a benefaction of £250,000 pledged under the Gift Aid Scheme from Mrs Jiehan Guo and Mr Vincent Zhao, payable over five years, to support the Cambridge Rivers Project in the Museum of Archaeology and Anthropology;
- (iv) a benefaction of £159,500 from DNV GL to support scholarships for international undergraduate students studying Mathematics, Physics, Engineering, or Chemical Engineering, to be known as Amy Li Cambridge Scholarships and to be matched and administered by the Cambridge Commonwealth, European and International Trust;
- (v) a benefaction of £117,000 from the Frances and Augustus Newman Foundation to support a Newman Foundation Next Generation Studentship in Chemistry for three years;
- (vi) a benefaction of £110,559 from the Polonsky Foundation, payable over two years, to support the Cambridge Interfaith Programme Summer Schools in 2014 and 2015.

The Vice-Chancellor has also accepted with gratitude a benefaction of £200,000 from an anonymous donor, to establish the Douglas Cashin Fund to support the study of Classics at the University, with a preference for providing assistance to those who might otherwise be deterred from such study by their financial circumstances. The Council is submitting a Grace to the Regent House (Grace 2, p. 105) for the approval of regulations to govern the Fund.

It is recommended that candidates take the equivalent of four three-unit lecture courses. At least nine units should be selected from the recommended list of courses above. Up to three units may be chosen freely from Part III of the Mathematical Tripos (and need not be relevant to astrophysics), or the allowed list of courses from Part III Physics in the Natural Sciences Tripos, or a mixture of both. The courses offered in Part III of the Mathematical Tripos vary from year to year and may be found in their lecture listing at http://www.maths.cam.ac.uk/lecturelists/PartIIIWeb.pdf. The allowed courses from Part III Physics may be found at http://www.ast.cam.ac.uk/students/undergrad/part_iii/lectures/. Students may be examined in up to a maximum of fifteen units in addition to their compulsory project. Students should consult the Part III Course Co-ordinator for guidance about choice of courses.

- **4.** Any unexpended income in a financial year may be accumulated for use as income in any one or more subsequent years, as the Managers may determine.
