Appointment of members of the Board of Scrutiny in class (c)(ii)

16 March 2015

Regulation 3 for the election of members of the Board of Scrutiny (*Statutes and Ordinances*, p. 121) provides that, if at an election insufficient nominations are received to fill all the places either in class (c)(i) or in class (c)(i), the Council shall appoint as many members as may be necessary.

No person having been nominated in the election for two members of the Board of Scrutiny in class (*c*)(ii) (members of the Regent House) in February 2015, the Council has appointed Dr Lydia Nicole Drumright and Mr Michael Kitson, *CTH*, to the Board with immediate effect until 30 September 2017.

Sale of the University Dental Practice

During 2012–13 and 2013–14, in the light of concerns about the financial position of the University Dental Practice and forthcoming changes in the nature of the NHS contract, the HR Committee, the University Health Services Management Committee, the Finance Committee, and the Senior Tutors' Committee were asked to consider the future of the Practice. There was consensus amongst these bodies that the Practice should be sold, but that in making the sale the interests of students should reasonably be taken into account by arrangements with the Health Authority and by suitable arrangements with a third-party purchaser.

The Pro-Vice-Chancellor (Institutional Affairs) convened a small group, on behalf of the Council, to consider the conclusions of the committees that had been consulted, and the matters that they had raised, and to make recommendations to the Council on the sale.

Under the terms of its current NHS contract, the Practice provides NHS treatment only to students at the University of Cambridge. However, the University has been given notice that the NHS contract will not be renewed under the same terms and therefore the Practice will be obliged to accept any patient who wishes to register at the Practice for NHS treatment, but with no corresponding increase in the number of NHS patients the Practice is able to accept.

The Council has accepted the recommendations of the group and gives notice of its intention to sell the University Dental Practice. In reaching this conclusion, the Council notes that there is sufficient availability of NHS places for students at other practices within the locality.

In consultation with the Senior Tutors' Committee, arrangements are being put in place to ensure that students continue to have good access to affordable urgent dental treatment. Consultation with employees of the Practice will be undertaken as applicable under employment legislation. In making the sale, the Council wishes to ensure, as far as it is able, continuity of treatment to patients currently under the care of the Practice under its new ownership.

- **1.** That Regulation 2 for the Catherine Grigoriou-Theocarakis Prize (*Statutes and Ordinances*, p. 838) be amended so as to read:¹
 - 2. The Prize shall be awarded by the Examiners for the Modern and Medieval Languages Tripos and for the Classical Tripos to the candidate who has shown the greatest distinction in one or more papers in Modern Greek, provided that he or she attains the standard of at least the second class in the Tripos examination of which the paper forms part. For the purpose of making the award the Examiners shall be empowered to take account either of an outstanding performance in a single paper or of the general level attained by a candidate in more than one paper in Modern Greek.
