# Honorary Degree Congregation and additional Flag Day and 'Scarlet Day', Wednesday, 3 November 2021

The Vice-Chancellor gives notice that a Congregation of the Regent House will be held in the Senate-House at 3.30 p.m. on Wednesday, 3 November, at which it is expected that the Chancellor will confer an honorary doctorate upon His Excellency António Guterres, Secretary-General of the United Nations. Conferral of this titular degree *honoris causa* was approved by the Regent House at a Congregation on Saturday, 24 July 2021 (*Reporter*, 6626, 2020–21, p. 762).

In keeping with the conduct of other Degree Congregations during Michaelmas Term and measures to prevent the spread of Covid-19, attendance will be restricted and the usual open application for tickets will not be possible, but in addition to the necessary ceremonial participants, representatives of the University and Civic communities will be invited to attend and the proceedings may be filmed.

In accordance with the relevant regulations, the Vice-Chancellor now designates Wednesday, 3 November as an additional 'scarlet day', when Doctors should wear their festal gowns in public and the academic dress of other Universities may in general be worn. The University flag will fly from the Old Schools on that day.

# Notice of a benefaction

#### 23 September 2021

The Vice-Chancellor gives notice that he has accepted with gratitude a bequest of approximately  $\pounds 200,000$  from the estate of Sir Richard van der Riet Woolley, to be held as endowment to support a full or partial Woolley Studentship in Astronomy. The Council is submitting a Grace (Grace 3, p. 7) for the approval of regulations to govern the Woolley Fund.

# Annual Report of the Council for the academic year 2019–20: Notice in response to Discussion remarks

#### 23 September 2021

The Council has received the remarks made at the Discussion on 26 January 2021 on the above Report (*Reporter*, 2021–20: 6601, p. 263; 6605, p. 344). It apologises for the delay in providing this response, owing to staff shortages.

Professor Evans reiterates several points made in previous remarks, repeated owing to the delay in publishing responses to them. Mr Allen also notes the delay to the Discussion remarks on the Covid-19 arrangements. These delayed responses have now been published, so the Council refers to them for the lessons learned, an explanation of the purpose of the University Emergency Management Plan, a definition of the Senior Leadership Team, and for the membership of those bodies that made decisions during the initial phase of the pandemic (*Reporter*, 2020–21: 6589, p. 4; 6627, p. 768). The Plan is an internal document to inform members of the University of the University's approach to emergency response and therefore is behind Raven; it is available as a link from the Emergency Planning website at: https://www.governanceandcompliance.admin.cam.ac.uk/audit-regulatory-compliance/emergency-planning/university-emergency-management-plan. The Plan sets out the membership of the Gold and Silver Teams, all of which are derived from the positions they hold. The Gold Team set up the Taskforces to advise it on operational matters; as noted in previous responses, where decisions go beyond the operational, they are referred to the relevant body for approval.

Information about the Recovery Programme was published in April and a response to comments made at a Discussion on that information has since been published (*Reporter*, 2020–21: 6613, p. 470; 6627, p. 769). The Notice published on 17 June 2020 confirmed that authority was delegated to the Chairs of the University's major decision-making bodies from mid March until mid May 2020, and the tables published on 17 and 24 June 2020 noted which decisions were made under that delegated authority (many decisions continued to be made under normal procedures) (*Reporter*, 2019–20: 6585, p. 454; 6586, p. 472).

Most of the material the Business Committee receives are drafts for publication, so members of the University can read what the Committee approved for publication in the *Reporter* shortly after its approval. This included the statement on key principles for teaching in 2020–21 (*Reporter*, 6585, 2019–20, p. 453). In the interests of transparency, the Business Committee has agreed from this point forward to make its minutes available to those with Raven access.

The Council is submitting a Grace (Grace 2, p. 7) for the approval of its Annual Report for 2019–20 (which incorporates the General Board's Annual Report).

# Arrangements for attending Discussions: Coronavirus (Covid-19) update

#### 23 September 2021

The Council expects Discussions in the Senate-House to resume from the beginning of Michaelmas Term, starting with the Discussion on 12 October 2021 (see p. 2 above and *Reporter*, 6614, 2020–21, p. 494). It reminds those wishing to contribute to Discussions that they need not attend in person; contributors may email remarks to contact@proctors.cam.ac.uk, copying reporter.editor@admin.cam.ac.uk, by no later than 10 a.m. on the day of the Discussion, for reading out by the Proctors,<sup>1</sup> or ask someone else who is attending in person to read the remarks on their behalf. Council recognises that some may wish to attend Discussions in the Senate-House and has therefore considered the measures necessary to mitigate health risks, in line with University guidelines developed in response to government advice.

The Council asks those wishing to attend a Discussion in person, including the officers in attendance, to note the following:

- It may be necessary to change the arrangements for a Discussion at short notice, for example, in response to a change in public health advice. Those planning to attend are therefore strongly encouraged to check the *Reporter* homepage (at https://www.reporter.admin.cam.ac.uk/) for any changes before travelling to the Old Schools.
- Attendees will be able to access the Senate-House via the gate immediately in front of the East Door from 1.45 p.m. on the date of the Discussion.
- As it may not be possible to maintain social distancing at all times in the Senate-House, those attending Discussions who are able to wear face coverings are strongly encouraged to do so.
- Those intending to wear gowns are reminded that for hygienic reasons they cannot borrow these at the Senate-House.
- Attendees are asked to abide by any additional instructions given for the purpose of maintaining a safe environment. Social distancing measures will be in place in the building, with an adjusted layout and appropriately spaced seating. A one-way system to enter and exit the building will be in operation and hand sanitiser will be available near the doorways.

The above arrangements will remain in place until further notice, and the Council will review them in the light of evolving public health advice. They are in addition to the rules that already apply to Discussions (*Statutes and Ordinances*, pp. 105 and 110, as amended by the Council and by Grace; see *Reporter*, 6614, 2020–21, pp. 496 and 526).

#### **Jeremie Prizes**

The Faculty Board of Divinity announces that the examination for each of the Jeremie Prizes to be held in 2021–22 will consist of two papers. The selected books or portions of books are as follows:

The Septuagint Prize: Exodus 1-20; Song of Songs.

The Hellenistic Prize: Wisdom of Solomon 1-10; 2 Maccabees; Josephus, Jewish War I.

Any member of the University is eligible provided that at the time of the examination not fewer than five complete terms have passed after their first term of residence or, if a graduate, they are of not more than ten years' standing from admission to a first degree whether of this or another university. A student to whom a Septuagint Prize has been awarded shall not again be eligible for a Septuagint Prize, nor shall a student to whom a Hellenistic Prize has been awarded again be eligible as a candidate for a Hellenistic Prize.

#### NOTICES BY THE GENERAL BOARD

#### Examinations and assessment, 2021–22

#### 28 September 2021

Following necessary changes to examinations and assessment in 2020–21, the General Board endorsed a framework for assessment for 2021–22 (*Reporter*, 6618, 2020–21, p. 661). The Framework recognises 2021–22 as a transition year and gives Faculties and Departments flexibility to select assessment methods appropriate to their needs. Details of these assessments are being collated by Education Services, overseen by the General Board's Education Committee. The Education Committee has also considered requests for assessment methods not included in the framework.

The Board is satisfied that this approach justifies the use of the authority granted by Graces 2–7 of 19 May 2021. It therefore gives notice that it has agreed to make the following changes to the standard arrangements for examinations in 2021–22:

- (a) The dates and the process concerning the form and conduct of any examination or part of an examination have been revised, and the normal three-hour duration of written papers waived. Definitive information on the form and conduct of examinations in 2021–22 is available on the websites of the Departments, Faculties and other institutions responsible for the course. This will, in some cases, supersede the information about the form and conduct of those examinations published in the *Reporter*.
- (b) There are likely to be temporary changes to examination regulations as part of the transitional arrangements anticipated by the framework, which will be published by Notice once those changes have been agreed. There are also some Notices setting out permanent changes to take effect from 1 October 2021, the publication of which has been delayed, as a consequence of the ongoing impact of the pandemic. The Board has therefore agreed to waive any General Board Regulations concerning the dates by which those Notices are to be published, provided that the Academic Standards and Enhancement Committee is satisfied that the changes do not affect candidates' achievement of agreed learning outcomes.

#### WOOLLEY FUND

1. The bequest received from Sir Richard van der Riet Woolley, together with such other sums as may be received or applied for the same purpose, shall form an endowment fund called the Woolley Fund to support students studying Astronomy in the University.

**2.** The Managers shall be responsible for the administration of the Fund and the application of its income and shall comprise:

- (a) the Director of the Institute of Astronomy who shall be Chair;
- (b) two members of the Institute of Astronomy appointed by the Faculty Board of Physics and Chemistry, who shall serve for such period as the Faculty Board shall determine.

**3.** Subject to Regulation 4, the income of the Fund shall be used to provide awards, which shall be called the Woolley Studentships in Astronomy. Arrangements for awards, including the number, tenure and conditions of Studentships to be awarded in any given year, the expenses to be covered by an award, and the form of the application and selection processes, shall be at the discretion of the Managers and may provide for applications by persons who are not yet members of the University and for the financial circumstances of candidates to be taken into consideration.

**4.** Any unexpended income in any financial year may, at the discretion of the Managers, be awarded in accordance with Regulation 3 in any one or more subsequent financial years.

**4.** That Regulation 1(i) of the Ordinance for the Military Education Committee (*Statutes and Ordinances*, p. 135) be amended to read as follows:<sup>4</sup>

(*i*) two persons appointed by the University of East Anglia, one by Anglia Ruskin University, and one by the University of Essex;
